- 6. Well-developed indoor and outdoor sports facilities. (Circular no. CBSE/AFF-11/2022 dated 04.10.2022).
- 7. Well-developed Digital Infrastructure (Circular No. CBSE/AFF-10/2023 dated 24.03.2023).
- 8. An operational website of the school may be ensured and upload Mandatory Public Disclosure As per appendix-IX of Circular No. 09/2021 dated 21.05.2021 and provide the revised link of the same.
